

$$\begin{split} &\sqrt{2}S_{n-1} + a_n < r \\ &\Rightarrow \sqrt{2} \left(2 \left(1 - \frac{1}{2^{n-1}} \right) \right) + \frac{1}{2^{n-1}} < \left(\frac{2^{199} - 1}{2^{198}} \right) \sqrt{2} \\ &\Rightarrow \sqrt{2} \left(1 - \frac{1}{2^{n-1}} \right) + \frac{1}{2^n} < \left(1 - \frac{1}{2^{199}} \right) \sqrt{2} \\ &\Rightarrow \frac{1}{\left(\sqrt{2} \right)^{2n}} - \frac{1}{\left(\sqrt{2} \right)^{2n-3}} < \frac{-1}{\left(\sqrt{2} \right)^{397}} \\ &\Rightarrow \frac{2\sqrt{2} - 1}{\left(\sqrt{2} \right)^{2n}} > \frac{1}{\left(\sqrt{2} \right)^{397}} \\ &\Rightarrow \left(\sqrt{2} \right)^{2n-397} < 2\sqrt{2} - 1 \\ &\Rightarrow 2n - 397 \le 1 \Rightarrow n \le 199. \end{split}$$

$$\begin{split} &\psi_1(x) = e^{-x} + x, \ \, x \geq 0, \\ &\psi_2(x) = x^2 - 2x - 2e^{-x} + 2, \ \, x \geq 0, \\ &f(x) = \int_{-x}^x \left(|t| - t^2 \right) e^{-t^2} dt \,, \ \, x > 0 \end{split}$$

and
$$g(x) = \int_{0}^{x^2} \sqrt{t} e^{-t} dt$$
, $x > 0$.

$$\psi_2(x) = x^2 - 2x - 2e^{-x} + 2, \ x \ge 0$$

$$\psi'_2(x) = 2x - 2 + 2e^{-x} = 2(x + e^{-x} - 1)$$

$$\psi'_2(\beta) = 2(\psi_1(\beta) - 1)$$

Since $\psi_2(x)$ is a continuous and differentiable function $\forall \ x \in [0, x]$

$$\psi_2(0) = 0, \ \psi_2(x) = x^2 - 2x - 2e^{-x} + 2$$

Hence according to LMVT there exist at least one $\beta \in (0, x)$ such that

$$\left(\frac{\psi_{2}(x) - \psi_{2}(0)}{x}\right) = \psi'_{2}(\beta)$$

$$\begin{split} &=\frac{\psi_2\left(x\right)}{x}=2\Big(\psi_1\left(\beta\right)-1\Big)\\ &=\psi_2(x)=2x(\psi_1(\beta)-1). \end{split}$$

$$\begin{split} \psi'_1(x) &= 1 - e^{-x} > 0 \\ \psi_2(x) &= (x-1)^2 + 1 - 2e^{-x} > 0 \text{ for } x = 1 \\ &\because \quad e^{-t} = 1 - t + \frac{t^2}{2} - \frac{t^3}{3} + \dots \\ &\sqrt{t}e^{-t} = \sqrt{t} - t^{3/2} + \frac{1}{2}t^{5/2} \dots \\ &\text{So,} \quad \sqrt{t}e^{-t} < \sqrt{t} - t^{3/2} + \frac{1}{2}t^{5/2} \text{ for } t \in (0,1) \\ &\int_0^{x^2} \sqrt{t}e^{-t} dt < \int_0^{x^2} \left(\sqrt{t} - t^{3/2} + \frac{1}{2}t^{5/2} \right) dt \\ &= \frac{2}{3}x^3 - \frac{2}{5}x^5 + \frac{1}{7}x^7 \end{split}$$

 $= n(E_1 \cup E_2) = 666 + 285 - 95 = 856$
 $= P(E_1 \cup E_2) = 856 / 2000 = 500\beta = 856 / 4 = 214$

- 18. Let E be the ellipse $\frac{x^2}{16} + \frac{y^2}{9} = 1$. For any three distinct points P, Q and Q' on E, let M(P, Q) be the midpoint of the line segment joining P and Q, and M(P, Q') be the mid-point of the line segment joining P and Q'. Then the maximum possible value of the distance between M(P, Q) and M(P, Q'), as P, Q and Q' vary on E, is _____
- Sol. 4

 M(P, Q) is mid-point of PQ

 M(P, Q') is mid-point of PQ'

 In a \triangle PQQ' since M(P, Q) & M(P, Q') are mid-point of PQ & PQ' hence line joining M(P,Q), M(P,Q') is parallel to QQ' and half of it. $\Rightarrow \max \text{ distance } = \frac{1}{2} \text{QQ'} = \frac{1}{2} (8) = 4$

then the value of 9I is _____

19. For any real number x, let [x] denote the largest integer less than or equal to x. If $I = \int\limits_0^{10} \left[\sqrt{\frac{10x}{x+1}} \right] dx \; ,$

$$I = \int_{0}^{10} \left[\sqrt{\frac{10x}{x+1}} \right] dx$$

$$\left[\sqrt{\frac{10x}{x+1}} \right] = n \Rightarrow \frac{n^2}{10 - n^2} \le x < \frac{(n+1)^2}{10 - (n+1)^2} \text{ where } n \in I$$
For $n = 0, 0 \le x < 1/9$

$$n = 1; 1/9 \le x < 2/3$$

$$n = 2; 2/3 \le x < 9, n = 3, x \ge 9$$

$$\Rightarrow I = \int_{0}^{1/9} 0 \cdot dx + \int_{1/9}^{2/3} 1 \cdot dx + \int_{2/3}^{9} 2 \cdot dx + \int_{9}^{10} 3 \cdot dx$$

$$= \left(\frac{2}{3} - \frac{1}{9}\right) + 2\left(9 - \frac{2}{3}\right) + 3(10 - 9) = \frac{182}{9} = 9I = 182$$
